• **Report on 9-6-19 Landscape walkthrough**: Tami reported that Artistree terminated the landscape contract on July 31 2019 it was a 30 day notice. The reason for the termination was that Artistree felt that with the watering restrictions they could not properly maintain the turf health effectively. Tami stated that the Board tried to address replacing the

irrigation heads on the larger yards in April, by June the work was not done. Artistree finally replaced the heads in July. Bloomings has replaced Artistree on August 9th

- On 9-6-19 there was a landscape walk through. It was determined that there is 15,000 sq ft of sod that may need to be replaced. The sod is suffering from take all root rot. Bloomings will be implementing a fertility program that may help with the root rot issue.
- Joe Lytle from Bloomings gave a presentation on the next steps and procedures on treating the root rot. Joe also had a question and answer session.
- Quentin Raines the irrigation manager from Bloomings gave a presentation on the current irrigation system in Palermo.
- 2020 Budget discussion: November 21st is the date for the budget meeting.
